

3. STRATEGY

- 3.1 Teachers will be responsible for the quality and content of the displays in their classrooms and teaching areas. Support staff will assist teachers in mounting the displays of work. Alison Flannery oversees general displays in school corridors
- 3.2 Displays should cover the full range of the curriculum and they should be informative and linked to teaching and learning to increase learners' knowledge.
- 3.3 All staff will provide learners' work for the shared areas of the school
- 3.4 Displays will be used to communicate high standards and high expectations of work and they should be combined with books and other resources to link them to the curriculum.
- 3.5 Where appropriate some displays should be three dimensional and they might incorporate materials, professional art work, artefacts and natural objects.
- 3.6 The school will establish a resource of materials, works of art, paintings, prints, artefacts and natural objects for use in display.
- 3.7 Teachers will be responsible to see that displays are changed regularly and kept up to date and in good condition.
- 3.8 Displays will reflect learners' creativity, imagination and originality.

4. OUTCOMES

When visitors enter the school they will be impressed by the quality and range of the displays of learners' work. The work on display will support and communicate our ethos to those who see it. The displays will make strong statements about the high quality and standards of work expected in our school. The displays will make this school a happy, bright and welcoming place for children, staff and all who come here.
